The minutes of the November 20, 2019 regular meeting, copies of which had been forwarded to the Board, were reviewed.

A MOTION WAS MADE BY KRISTINE JARDEN AND SECONDED BY KERRY BERTELS THE NOVEMBER MINUTES BE APPROVED. MOTION PASSED WITH THOMAS ABSENT.

The Treasurer's Report, copy of which had been forwarded to the Board, was reviewed and questions answered. Income reported for November \$191,338.62, bank interest \$7,500.46, expenses \$152,602.28 and depreciation \$38,729.90 resulting in a profit of \$7,506.90. Transfers among accounts for the month were also reported.

A MOTION WAS MADE BY STEVE RUPPERT AND SECONDED BY ROBERT KERCHER THAT THE TREASURER'S REPORT BE ACCEPTED AS PRESENTED. MOTION PASSED WITH THOMAS ABSENT.

O & M bills, previously sent to the Board, were presented along with additional bills for discussion and payment approval and questions were answered.

### **OLD BUSINESS**

DELGATIONS: Seth from Heneghans was present to discuss the Seiler Rd project and water treatment plant.

ILLINOIS ALLUVIAL WATER PLANT – Seth reported the City of Jerseyville sold their water and sewer systems to Illinois American Water. Manager presented purchase agreements to review and decide if the board wished to go exclusively with the water treatment plant when it is built so our attorney can look at it. Their board needs an answer in February.

A MOTION WAS MADE BY ROBERT KERCHER AND SECONDED BY EUGENE FELDMANN TO SEND THE EXCLUSIVE CONTRACT TO THE ATTORNEY FOR HIS REVIEW BUT TO ADD AN EMERGENCY CLAUSE IN THE EVENT THEY CAN NOT PROVIDE THE WATER. MOTION PASSED WITH THOMAS ABSENT.

SEILER RD PHASE II – Seth, the Chairman and Manager met with the Transportation Committee at Madison County to discuss the options for Phase II. They asked if FWD would proceed and begin moving the line while they reviewed the map Heneghans provided. They would have a decision on the split in a month or two.

A MOTION WAS MADE BY KERRY BERTELS AND SECONDED BY STEVE RUPPERT TO WAIT ON STARTING THE PROJECT UNTIL WE HAVE AN ANSWER FROM THE COUNTY ON THE COST SPLIT. MOTION PASSED WITH THOMAS ABSENT.

#### WORK REPORT:

Manager reported the O&M workers clamped a leak on Culp Ln, checked leaks, did maintenance on the dump truck and box truck, and replaced tongue jack on backhoe trailer. There has been on issue with the lid and frames from Midwest Meter for some time, manager found some that snap together and brass cheaper else where.
