The regular meeting of the District Board was called to order by the Chairman at 7:00 p.m. at the District office. Additions to the agenda were O & M bills for approval.

**DELGATIONS:**

The minutes of the November 19, 2025 meeting, copies of which had been forwarded to the Board, were reviewed.

A MOTION WAS MADE BY ROBERT KERCHER AND SECONDED BY KERRY BERTELS THAT THE MINUTES FOR THE NOVEMBER MEETING BE APPROVED ONCE ADDING “DAYS” TO THE VACATION AMENDMENT. MOTION PASSED UNANIMOUSLY.
