SEILER RD PHASE II – Mr. Newton was not pleased with the easement proposed on Wenzel Rd. Seth and Mark have looked into new options – the district could pay \$16,000 for this easement. The board agreement to wait until the county settles on a reimbursement amount before committing to the easement.

ILLINOIS ALLUVIAL WATER PLANT – Carlinville court case is back in the county court – appellant court kicked it back. The alluvial board needs an answer on the district decision to buy from them in order to plan the size of the plant. JCRW will build the plant if no one else is able to participate in the operations. Carlinville's grant was for the study and they can use the money to build their transmission line if they are unable to be on the board. The board agreed to allow the manager to contact Rammelkamp and find out what his availability and cost would be to review the contract. A special meeting may be called if anything happens on the Macoupin County case.

BACKHOE TRAILER – Martin has a 24,000 lbs trailer for \$16,900. Plaza offered \$1,000 for old one but we will have to post a bid for sale.

DUSTMAN RD – Piazzo is building on the portion of the road which is not currently serviced. 2 taps cost \$5,000 to complete the line.

NESS SCHOOL RD EXTSION -23 surveys were sent out and we received 14 back (13 yes & 1 no) LMI 50% need 51% to apply for grant on construction. 150-175k out of pocket for engineering. 175k would be our cost to do the work. The manager will contact the remaining residents who did not respond.

RECYCLING BINS - Township has asked permission to place recycling bins on FWD lot.
