The Fourth Quarter Investment Report, a copy of which had been forwarded to the Board, was reviewed and questions answered, gained \$41,440.71.

A MOTION WAS MADE BY KERRY BERTELS AND SECONDED BY FRED BORT THAT THE FOURTH QUARTER INVESTMENT REPORT BE ACCEPTED AS PRESENTED. MOTION PASSED UNANIMOUSLY.

The Annual Investment Report, a copy of which had been forwarded to the Board, was reviewed and questions answered, gained \$124,593.27. Treasurer asked if some funds from the loan savings should be moved to a CD since they won't be need for awhile.

A MOTION WAS MADE BY ROBERT KERCHER AND SECONDED BRAD HUETTE THAT THE ANNUAL INVESTMENT REPORT BE ACCEPTED AS PRESENTED AND TO INVEST \$300K FROM LOAN SAVINGS TO A SHORT TERM CD. MOTION PASSED UNANIMOUSLY.
