MINUTES – BOARD MEETING  
September 17, 2025**

The regular meeting of the District Board was called to order by the Chairman at 7:00 p.m. at the District office. Additions to the agenda were O & M bills for approval.

Roll was called with the following board members present: Steve Strohbeck, Steve Ruppert, Kerry Bertels, Robert Kercher, Brad Huette, Tricia Sisk and Jacob Goebel were present. Also present were Mark Voumard and Kim Owens.

**DELGATIONS:**

The minutes of the August 20, 2025 meeting, copies of which had been forwarded to the Board, were reviewed.

A MOTION WAS MADE BY BRAD HUETTE AND SECONDED BY KERRY BERTELS THAT THE SEPTEMBER O & M BILLS BE APPROVED FOR PAYMENT AND CHECKS BE ISSUED. MOTION PASSED UNANIMOUSLY.
